Mayor Pearson called the meeting to order at 7:20 p.m.

September is Cancer Awareness Month. There are about 10,000 children living with cancer in Canada today. Each year, about 1,600 cases are diagnosed; over 25 of which are children in Newfoundland and Labrador. Because of significant advances in therapy, 78% of children diagnosed with cancer will survive five years or more, an increase of almost 46% since the early 1960s. Childhood cancers have close to a 75% cure rate, with leukemia leading the success charge with close to 90% overall cure rate. Council signed a proclamation in support of Cancer Awareness Month.

On behalf of Council, Mayor Pearson thanked Mr. Angus Gilbert for his years of dedicated service to the Town. Mr. Gilbert's retirement from the position as Town Crier was acknowledged at the Historic Society's Tea Party at which Council's representative, Councillor Kay Smith presented Mr. Gilbert with a Certificate of Appreciation and a gift from the Town. Bert best wishes are offered to Angus in his retirement.

Congratulations were also extended to James Newhook and Angus Gilbert who where this year's recipients of Heritage Awards from the Historic Society.

The Hike Placentia team and its volunteers were commended on the wonderful work they are doing with cleanup and trails clearing. Recent damage has been repaired and Council made note that the Town will be taking steps to identify vandals through patrol, camera monitoring and policing.

Pearl Celebrations and the Voices of Placentia Pay Festival were resounding success this year. Mayor Pearson took a moment to thank all staff, volunteers and participants for contributing to that success. A special thanks to those who 'came from away' to take part in our celebrations!
